Miss Cinco de Mayo QUEEN CODE OF CONDUCT

1. Contestant affirms that she has not committed any act and will not commit any act inconsistent with the highest standards of public morals that will reflect unfavorably on the pageant, its organizers, or sponsors.
 2. Contestants and delegates will conduct themselves in a courteous and respectful manner at all times during the pageant and while representing Shelby County.
 3. Delegates will not slander other contestants, judges, organizers, or anyone involved with or connected to the Miss Cinco de Mayo and/or title.
 4. All contestants prior to the pageant must agree to not post on social media and/or other sites presenting them in any inappropriate settings/situations.
 5. Must be in good standing with the community and local law enforcement.
 6. Students must not violate the school's code of conduct or be assigned to ISS or DAEP.
 7. Good sportsmanship is expected at ALL times. Disruptive behavior before, during, or after the pageant will result in removal from the premises and possible disqualification. Removal from the premises applies to contestants as well as parents and spectators
- * Failure to abide by these rules may result in disqualification and/or forfeiture of the title and any prizes won. This determination will be made by the pageant board.**

Miss Cinco de Mayo WINNER'S CONTRACT

1. If selected as a Miss Cinco de Mayo Queen, the winner must agree to sign a contract stating to make appearances and meetings throughout her year's reign. ***No more than 2 appearances and/or meetings will be allowed to be missed.**
2. You must obtain at least 15 community service hours in Shelby County outside of scheduled appearances. **This applies to Teen Miss and Miss Divisions only!**
3. Must maintain proper upkeep of your crown and sash so that they stay presentable.
4. Hair must be kept in a **NATURAL** shade and must properly be groomed for appearances.
5. All winners under 16 must be accompanied to public appearances with an adult chaperone.
6. All winners must agree that she will not enter any other pageant or compete for any other title during her year's reign.
7. Miss Cinco de Mayo winner is expected to give a considerable amount of time and effort to this title during her year's reign. For Example but not limited to making all meetings, scheduled appearances, and coordinating with pageant board.
8. All winners must agree to attend next year's pageant to crown her successor.
9. All winners must enter into the Center, Texas Christmas parade.

***If a delegate is unwilling to sign the contract, unable to fulfill obligations, or is found in violation by the pageant board of this contract, the title and all prizes won will go to the first runner up.**

Pageant Information- Judging Categories:

Baby Miss, Toddler Miss, Tiny Miss, Petite Miss, Jr, and Pre-Teen Divisions -Evening wear, sportswear or casual wear, and most photogenic. Evening wear may be long or short.

Teen Miss, and Miss Division-Contestants will be judged in evening wear (must be long), sportswear or casual wear, most photogenic, and on stage interview. **Contestants are responsible for selecting a platform and must be prepared to speak on this issue on stage.**

Cover girl-Presented to the contestant submitting the most money from AD sales, ticket sales, or donations. She will receive a tall sparkling stone tiara and sash. Her picture will be on the cover of the pageant program booklet.

Each contestant will receive a tiara to remember this special occasion. Winners in each category will receive a tiara, a trophy, monogrammed sash.


