THE UNKNOWN HEIRS OF RONALD J. CLARK, DECEASED, et al.** The Special Commissioners' Hearing will be held on **August 13, 2026, at 10:00AM, at the Best Western Plus Classic Inn & Suites, Conference Room, 210 Moffett Dr., Center, Texas 75935**, which is the earliest practicable date following the expiration of forty-two (42) days from the date of this notice, in compliance with Texas Rules of Civil Procedure and the Texas Property Code.

At the hearing, the Special Commissioners will meet and proceed to hear evidence from all parties present in order to determine the value of and assess the damages, if any, caused by the condemnation of certain property interests described in Plaintiff's First Amended Statement and Petition for Condemnation filed with the District Clerk of Shelby County on June 11, 2026, or any subsequent amended or supplemental petition filed by Plaintiff.

You may appear and present evidence at the hearing. If you desire to appear before the date of the hearing, you may do so by filing a notice of appearance in the above-styled and numbered lawsuit. You may employ an attorney. A judgment in the absence of objections rendered for the relief demanded in the live petition may be taken if you or your attorney do not timely file objections to any award by the Special Commissioners.
