At that time the agency served Shelby, Sabine and San Augustine counties. In 1977 the Head Start program expanded into Angelina County. In 1984 it expanded into Jasper, Newton and Tyler counties. In 2001, we expanded all services except Head Start into Harrison, Panola and Upshur counties. Over the years the organization has continued to fight the debilitation effects of poverty through many innovative programs. During this time, the local communities have remained actively supportive of Tri-County. The promise of Community Action is to change people's lives, embody the spirit of hope, improve communities, and make America a better place to live. We care about the entire community, and we are dedicated to helping people help themselves and each other.

Local residents serve on the Board of Directors and Policy Council, as well as volunteer their time, skills, goods and services to help Tri-County be successful. Tri-County works closely with other service agencies in the area to ensure coordination of referrals and services. Currently, Tri-County administers three major programs, and maintains a staff of one hundred fifty (150) employees. An eighteen member Board of Directors oversees the agency. TCCA is an agency directed by concerned citizens working for concerned communities.

Based on community needs the agency will focus on Jobs/Employment, Educational Needs (including childcare), Healthcare Access, Affordable Housing & Transportation needs. TCCA has enjoyed serving these past 50 years and excited about addressing community needs for the future.





FAQs Do I talk to "real doctors"?

Yes. Teladoc members only talk to actual doctors who are U.S. board-certified internists, statelicensed family practitioners, and pediatricians licensed to practice medicine in the U.S. and living in the U.S. When you request a consult, Teladoc will connect you with a doctor licensed in your state. What are some of the common conditions Teladoc treats?

Common conditions include sinus problems, respiratory infection, allergies, urinary tract infection, cold and flu symptoms and many other non-emergency illnesses.

Can Teladoc handle my emergency situations?

Teladoc is designed to handle non-emergent medical problems. You should NOT use it if you are experiencing a medical emergency.

Can I get a prescription?

Teladoc does not guarantee prescriptions. It is up to the doctor to recommend the best treatment. Teladoc doctors do not issue prescriptions for substances controlled by the DEA, non-therapeutic, and/or certain other drugs which may be harmful because of their potential for abuse. These include, but are not limited to, antidepressant drugs such as Cymbalta, Prozac and Zoloft which are drugs that are harmful due to their potential for abuse. Also, non-therapeutic drugs such as Viagra and Cialis are not prescribed by Teladoc doctors.

Can I be turned down for a pre-existing condition?

We do not turn patients away because of preexisting conditions.

Can I call Teladoc outside of the United States? You can request a Teladoc consult from anywhere in the U.S. You will speak with a doctor licensed in your home state. You must have a U.S. address and a U.S.-based phone number for the doctor to call back at the time of consult.

She recently held a Parent Appreciation in this Summer that celebrated lots of family goals such as obtaining a Driver License, GED, employment, first-time car buyers and new businesses. Over the past month, she has started a program with the Head Start Dads to get them involved in their child's education and activities. Saundra also works with our Social Services Department by being an advocate for our parents to help transition them out of poverty and lead into entrepreneurship by creating small goals that create a pathway of ownership and life long success. Ms. Christopher has been with the agency for over 5 years. Her main objective is to help families become self-sufficient and self-involved in their children's lives, because all children matter.

Top 8 Safety Issues in Head Starts

1. Lack of Adequate Supervision Anytime you have a group of kids without enough adult supervision, you're asking for trouble. "Infants and toddlers should be in-sight at all times and young children should be supervised at all times," says Glassy.

2. Staff is Under-Trained

The single best way to improve safety and prevent injury is to have sound health and safety policies that all teachers and caregivers are taught and follow,

Medication Administered Improperly When medications are given carelessly or improperly dosed, poisoning can happen.

- 4. Sudden Infant Death Syndrome (SIDS) Providers should:
 - Put babies to sleep on their backs.
 - Never place bumper pads, fluffy blankets or toys in cribs.
 - Avoid soft bedding.



5. Presence of Poisons and Toxic Substances According to Child Care Aware, accidental poisoning is a leading cause of injury and death among young children.

Illness Transmission

Day care centers can be germ factories. "Providers should have proper cleaning, sanitizing and disinfecting policies and practices in place to prevent the transmission of illness"

7. Lack of Food Safety

Food-borne illnesses can result from improper handling of food. Centers should also be wellversed on proper handling and storage of breast milk and formula for their youngest customers.

8. Lack of Background Checks

You should always make sure that the day care is licensed by the state, but these licenses don't necessarily guarantee that staff and other employees have undergone background checks. Fraga reports that only 13 states require comprehensive background checks for staff in child care centers, and only 11 states require them for individuals who have home child care businesses.

Providers should:

- Make sure everyone in contact with children has had an extensive background and criminal screening.
- Keep at least two adults with each group of children most of the time.

Have You Had Your Yearly Exam?

An annual exam is part of your health care. If it has been more than 12 months, please contact your health care provider to schedule an exam. What is an annual exam?

An annual exam is a once-a-year visit to your primary care provider for a general health check, including a breast exam and pap smear. An annual exam visit does not include discussion of new problems or detailed review of chronic conditions. Annual exams are also called routine check-up, yearly exam, annual pap, and preventive visit.

Please schedule a separate appointment if you have health concerns other than your routine physical exam. Examples are:

•A list of concerns or questions.

•New health care concerns or problems found at the time of your annual exam.

•Ongoing health problems that need more attention.

•What should I expect during my annual

exam? General physical exam (including breast exam)

- •Pelvic exam (pap smear)
- •Update of life and work situation
- •Update of family health history (any new
- serious illnesses in your family?)
- •Review of your health history
- •Update of current medications, herbs, and supplements (bring list)
- Need for medication refills
- •Evaluation of need for health screening tests based on age and personal and family history (such as mammogram, test for sexually transmitted diseases, and colon cancer screening)
- Update on immunizations

Register for Assurant Online Advantage and receive your \$50.00 wellness refund, once you have had your yearly checkup. Claims can be submitted for Accidental/Critical Illness and Cancer.

What happens if you have a new health problem when you come for your annual exam?

You and your provider will need to decide whether to use the time that day to address your problem, in which case your annual exam visit can be rescheduled. Or you may choose to go ahead with your annual exam, and to defer the health concern to another visit. Scheduled appointment times do not allow for both.

Insurance Coverage Issues:

•Please check your insurance policy to make sure you are covered for yearly preventive medicine visits or women's health pap/pelvic/breast exam. Different insurance policies have different rules for preventive care coverage.

• Most insurance companies allow for only one annual exam per 12-month period (and some will not pay for a visit even a few days before the your is up).

Medicare Issues

•Medicare covers paps every two years,

mammograms every year, colon cancer screening, and routine vaccinations.

• If you are considered high risk, Medicare will pay for annual pap smears.

•Medicare does not cover routine annual exams. You may choose to pay for routine physicals and tests out-of-pocket.


